Kurlander then spent four years at Citadel, one of the world's largest and most sophisticated global hedge funds, where he became Deputy Global Treasurer, covering the hedge fund as well as Citadel Securities. Kurlander spent the last two years as Chief Financial Officer of Pagaya Technologies, a publicly traded fintech firm that helps consumers access credit and is the largest US issuer of securitizations backed by personal loans. Kurlander earned his BS from University of Maryland and his MBA from Columbia University. He has successfully completed CPA, Series 7, and 24 licenses.
